Kristine Dorrain:a U-label is a unicode translation of a domain name - I am not sure if there is some other interpretation of U-label, but Karen may have answered your underlying question.

Gustavo Lozano:@Greg, SANDY is a NR-LDH

Greg Shatan:NR-LDH?

George Kirikos: Thanks Kathy.

George Kirikos:Official languages? So Canada = English AND French?

Mitch Stoltz:Thanks Mary

Kathy Kleiman:Tx!

Gustavo Lozano:@Gred, the code points are within the ASCII repertoire in the case of SANDY

Greg Shatan:@Kristine, I thought U-label was one of the data fields in the SMD even for an ASCII mark.

Mary Wong: All of the terms on this Slide 11 are defined in the Functional Spec.

Greg Shatan:@Gustavo, thanks for the ink.

Greg Shatan:link

Kristine Dorrain:@Greg, I see what you're asking now. So in order to have a TMCH match for a U-label, the SMD file has to also have a corresponding U-label. Got it. Thanks.

Kristine Dorrain:Remember individual ROs can add different layers of Sunrise...

George Kirikos: That example probably won't generate a NORN, though?

Kristine Dorrain: for instance, city TLD can have a sunrise for city-specific marks and they don't need ot use the TMCH for this, though they could.

George Kirikos:(if a different registrant registered Johns.Tattoo, and the mark was "Johns Tattoo".

Kristine Dorrain:@George, I don't see how it would.

Mary Wong:Not sure if this helps, but what Karen is describing is limited to what the specific ICANN rules require as to Sunrise and Claims (not additional sunrise eligibility requirements and/or other processes offered on a voluntary basis by some registries).

Kristine Dorrain:+1 Mary

Kathy Kleiman:@Karen: could you explain what a U-label is?

Kathy Kleiman:tx -- does every domain name have a U-label?

Kathy Kleiman:or only IDNs.

George Kirikos:They can reverse engineer much of the list, through bulk checking, though.

Maxim Alzoba: TLD does not have info about other TLDs

Martin Silva:Of curse is not about pricay, is trade secret, but non the less, having a transparent db is the rule in trademark registries around the world

Martin Silva:that also "reveals" commercial strategies

Martin Silva: is not the end of anything

Jonathan Frost: Thanks!

Marie Pattullo:Martin - we've talked about this at length here before about this. Having registered TMs and choosing which of those TMs you wish to put in the TMCH are 2 very different things.

Martin Silva:we might have talked lenght about it, I still have my view :-)

Marie Pattullo:Or we could also ask for domainers' lists of DNs to be in a public list too...

Maxim Alzoba: please be aware that TMCH has no SLAs before Registries or Registrars, and can formally not be reachable (happened few times, for quite large windows of time)

Martin Silva: I wasn't convinced in those talks, but I did learned a lot of the different valid points

George Kirikos:@Marie: see the zone file for nearly all of the domains.

Marie Pattullo: Views are good to have. Just time-line concerns. :-)

Martin Silva:@Marie, as you said, one would breach privacy, the other one only commercial strategy

Martin Silva: different issues

Griffin Barnett:@George I don't think the zone files, though, indiciate who the registrant of each domain name is

George Kirikos:@Griffin: we don't need to see the owner of each TM in the TMCH, just the TM.

George Kirikos:Better

Mitch Stoltz:Sounds like the secrecy of the TMCH is an issue that is far from resolved.

Martin Silva:I am not remotely convinced

Mary Wong:Note that there are several open questions about the TMCH structure/operations that the WG is supposed to return to after analysis of the Sunrise and Claims survey results is done. This includes the TMDB.

Marie Pattullo:I am.
