Jean-Baptiste Deroulez: (09:20) comment from NCSG: While there is a short list of terms in the appendix, we recommend for ease of reference that the first time an acronym is used, it be spelled out in its entirety. Given the length of this report, it would be a good idea to repeat this in each main section. An acronym list for easy referencewould be helpful as appendix A. Similarly,

the presentation of the report was not as thoughtful as it could have been, with sentences continuing across pages (where a page break could have added clarity) and the formatting not contributing to the report's legibility. The report could have also benefited from being proofread, as there were numerous typographical errors throughout. The naming and cross-referencing of recommendations from one Review Team to the other are somewhat confusing (for example, CM4, R1, R1.1, LE 2). We suggest including a cross-reference index in the appendices and the executive summary, or to simply stick to the recommendations of the first review for numbering, not the sub-teams.

Stephanie Perrin: (09:40) the balance between HR and Public safety is not reflective of reality in most democratic states

Carlton Samuels: (09:41) @ Alan: Since RSG is of the GNSO Council, take their suggestion aboard and extend coverage of the recommendation to the Council as well!

Carlton Samuels: (09:42) @Volker: +1, yes, recognizing policy development as GNSO Council can advise Board to pass on

Jean-Baptiste Deroulez: (09:44) @ Volker, in its pc, it was reported for this recommendation.

Carlton Samuels: (09:44) @ Alan: That is to be rejected on its face! How can you call for more outreach unless there is spending? Let's reinforce the proposal by saying more about the planning and wise spending of the funds!!

Jean-Baptiste Deroulez: (09:53) @ Alan: full comment from Domain Name Rights Coalition: Dangerous recommendation for registrants, which should be removed as untimely and beyond scope, or narrowed in express language, to a more narrowly-tailored intent of the RDS/WHOIS2. As the ICANN Community engages actively and with an extraordinary effort in the EPDP, which includes a review of what registrant data fields are appropriate in 2018 and ahead, why would the RDS/WHO2 be calling on the ICANN Board and Staff to mine the existing WHOIS database for "errors"?

Carlton Samuels: (09:55) @ALan: If you look at the new Compliance Reports, some of that is already happening. When you collect more of this kind of data that delivers these new results you can begin making predictions!

Carlton Samuels: (10:02) @ Alan: I emphatically disagree! The need for keeping accurate data is recognized in privacy law. In fact it allows the data subject to access and demand corrective action. So the data controller has a duty of care to see accurate data is curated.

Carlton Samuels: (10:04) @ Alan: Accuracy of data is a proactive requirement for the data controller!

Volker Greimann - RrSG Alt 2: (10:07) Carlton: You fundamentally misinterpret the accuracy requirement of the GDPR

Volker Greimann - RrSG Alt 2: (10:07) Data accuracy is a data subject right.

Carlton Samuels: (10:07) @Jean-Baptiste: Thanks again!
