The RDS-WHOIS2 Review Team undertook the following during this session:

1. Welcome, roll-call, Statement of Interests

There were no updates to Statement of Interests.

2. Face-to-Face Meeting #4

3. Draft Report: Review of Public Comments Received

Review team started reviewing the public comments received on the draft report, focusing on three of them:

- Domain Name Rights Coalition,
- Registrar Stakeholder Group (RrSG),
- Non-Commercial Stakeholders Group (NCSG).

Their public comments were reported for the following recommendations: BY.1, R1.1, R1.2, R3.2, R4.2, R5.1, R11.1 and LE.1.

BY.1

Action item: Reword recommendation to make sure that “safeguard registrant data” are incorporated into it.

R1.1

Action item: Emphasize in recommendation that the focus should be global as opposed to either just Europe or just the US.

R1.2

Action item: Review team to consider extending coverage to the recommendation to the council as well.

R3.2

There was no decision reached, review team will reconsider the need for this recommendation at the upcoming face-to-face.

R4.2

There was no decision reached, review team will reconsider the need for this recommendation at the upcoming face-to-face.

R5.1

Recommendation will be updated in Brussels, including with elements from the discussion with ICANN Contractual Compliance in September on ARS.

R11.1

Alan Greenberg suggested deleting this recommendation based on public comments received.

LE.1

Discussion is moved to the face-to-face meeting.
