Erich Schweighofer: (14:26) We should change the language "agreed to prioritize" to the new version.

Milton Mueller: (14:26) very minor editorial - boldface Annex E

Bernard Turcotte - ICANN: (14:26) will do

Thiago Jardim: (14:27) Can you comment again on the bit "agreed to prioritise"

Raphael Beaugregard-Lacroix 2: (14:27) nice catch Erich!

Thiago Jardim: (14:27) this is not wholly accurate, there was no agreement on that.

Milton Mueller: (14:27) the new language reflects that Thiago

Thiago Jardim: (14:28) What's the new language, could you please copy and paste it here?

Milton Mueller: (14:28) Thiago

Milton Mueller: (14:28) just "the group prioritized" rather than "agreed to prioritized"

Thiago Jardim: (14:30) which makes 2 on this call, against perhaps 5 favourable votes.

Thiago Jardim: (14:30) I suggest it would be a fairer description of the group's view not to portray it as consensus

Thiago Jardim: (14:30) but you should call a poll

Thiago Jardim: (14:31) I suggest the voting be postponed until the end of today

Cheryl Langdon-Orr: (14:31) we have I believe consensus

Milton Mueller: (14:31) what part of the consensus do you not support, Thiago

Thiago Jardim: (14:31) so that people on the list be given an opportunity to react

David McAuley: (14:31) I agree with Greg's handling

Robin Gross: (14:31) We have consensus.

Thiago Jardim: (14:31) Milton, I oppose the report to the extent it left out the issues we consider central.

Milton Mueller: (14:31) which issues were those?

David McAuley: (14:32) and the plenary call next week

Robin Gross: (14:32) All my points don't get in documents either. They tell me to file a dissent.

Cheryl Langdon-Orr: (14:32) raise that in the plenary

Thiago Jardim: (14:32) I'm re-raising the point here, so it can be raised in the plenary.

Finn Petersen, DK: (14:32) Wow - it was an effective meeting and a good result
