- Carlton Samuels:Too many issues re conflict etc!
- Gisella Gruber-White:Olivier - we will call you as soon as you drop
- Carlton Samuels:The declaration of the vote DID make the list!
- yaovi Atohou: I voted
- Heidi Ullrich:Thanks, Yaovi.
- Olivier Crepin-Leblond:Thank Yaovi. At least one person who remembers!
- yaovi Atohou:On Inter-registrar ..... Part C ....
- Heidi Ullrich:Unfortunately, there is a technical issue with BP at the moment. We will announce the current number of votes later today.
- Heidi Ullrich:Apologies for this.
- Natalia Enciso:I did too, today ( IRR Part C)
- Heidi Ullrich>Please state your name before speaking. The interpreters need to know.
- Evan Leibovitch:Sorry.In my conversations with NCSG, the concept of protecting users against fraudulent domains is having a rough ride.
- JJS:My line has just been dropped.
- Evan Leibovitch:There is a belief, apparently widely held in the NCUC, that there is no such thing as a "fraudulent domain"
- Sandra Hoferichter:sorry
- JJS:am back on the call.
- Alan Greenberg:currently voting on ALAC statement on IGO protections.
- Eduardo Diaz:I agree
- JJS:sorry Olivier, I did not hear the question.
- Dave Kissoondoyal:it is only for ALAC Members
- Carlton Samuels:@ratification of Prelim GNSO Issues Report on IGO: I agree to ratify!
- Evan Leibovitch:(You know, we could do the agree and disagree votes at the same time ;-))
- Carlton Samuels:@Evan: Not to be pedantic but I think what they really mean is that the USE of the domain is fraudulent, not the name itself!
- Gisella Gruber-White:REMINDER - Please state your names
- Gisella Gruber-White:for the interpreters
- Carlton Samuels:Is like me saying a string is a string and can only be considered as bad on interpretation!
- avri:Re NCUC and that it is impossible to determine a-priori which string will be misused.
- Evan Leibovitch:@ Carlton: I agree in that reading of the PoV. There is disagreement that a string such as "redcrosssunamirelief.com" is, itself, fraudulent in intent.
- avri:Evan: it could be a site the displayed pictures and pointed people at the genuine red cross fund raising site
- Gisella Gruber-White:Carlton is unmuted
- Evan Leibovitch:It could be. But the issue is that it could just as easily not be. What is unclear is whether it is in the public interest to have sites like that that are appropriate the redcross name to attract viewers and SEO, without being assured of pointing people to the red cross itself
- Evan Leibovitch:itself
- Evan Leibovitch:sorry... not sites like that. That's beyond ICANN. The issue is "domain names like that"
- Evan Leibovitch:how can you see if I'm jumping up and down?
- Carlton Samuels:When domain names impinge on marks, then it is violative of an IP but could not in itself be declared fraudulent ALTHOUGH the intent might be indeed fraudulent
- avri:Evan: of course it is in the public interest to stop people from doing bad stuff, the main point is that there is not way to know a-priori which is which.
- Carlton Samuels:@Evan: Yes, we agree on that
- Sebastien:May I suggest that for the SSR RT ALAC do a advice to the board out of the comment period?
- Carlton Samuels:@Avri on a priori treatment: +1
- Sebastien:As it is chair by an ALAC suggested persone
- Evan Leibovitch:@avri: agreed. I don't think that anyone here is demanding prior restraint (ie, reserved or restricted names). The point is to try to open a broader discussion that may identify other solutions,
- Carlton Samuels:@Evan: Yes to broader discussions +1
- Evan Leibovitch:Olivier, I have one item to add to the list
- Olivier Crepin-Leblond 2:ok
- Olivier Crepin-Leblond 2:I'll come to you in a moment
- Evan Leibovitch:ok
- Carlton Samuels:I will have to leave at 25 past the hour for a commitment.

For this TLD, four different levels of whois are available from the registry, varying from thin to thick, depending on who you are, how you ask, and whether you have been pre-authorized for the full (thickest) whois. This is similar to what has been recommended for thick whois to meet data privacy legislation, and so is close enough that we do not need a comment.
