Carlton Samuels: It is afterall 'whosoever will may come'. But it cannot be 'everyone has the same weight of decision-making regardless of knowledge or demonstrable interest'!

Evan Leibovitch: Just to say that I am fundamentally opposed to the GNSO's decision to do an implementation-versus-policy working group in a silo separate from the rest of the ICANN community. The Board should be DIRECTING that this be a cross-community group. Just having (non-voting) ALAC participants in a GNSO group is IMO absolutely pointless.
Jean-Jacques S.: @Evan +1
Jean-Jacques S.: Because, seen from the Board, "policy" = Board, "implementation" = CEO & Staff; the rest is "comment" ...
Rinalia Abdul Rahim: @ Alan, I agree that the questions are new. I think Edmon wants to respond to those questions.

Alan Greenberg: I agree that it would have been encouraging for the Board to have taken some more "community-based" action. Given the difficulty that has been experienced in CWGs before, I think the GNSO would have been crazy to embark on that part themselves. It is unfortunate that the various

Chairs of bodies that care did not choose to get together and jointly recommend chartering a joint group (as they did with DSSA). Or maybe they tried and it didn't succeed.

Alan Greenberg:BTW, to the extent that WGs vote, any At-large members DO have a vote within the WG. It is on the GNSO that we don't. But as has been evidenced in the IGO/INGO WG, we can influence where things go. And of course, we don't always win...

Cheryl Langdon-Orr:correct the record OCL PY will join ccNSO on May 31

Holly Raiche:@OLC - I really cant do my report until the APRALO call - today. Will do the report for tomorrow

Cheryl Langdon-Orr:read correction please

Natalia Enciso:Great news CLO, thanks

Gisella Gruber-White:@ Natalia - yes

Rinalia Abdul Rahim:It is important that the statement is balanced - pointing out the issues that the ALAC agrees with and support as well as the concerns that the ALAC has.

Rinalia Abdul Rahim:I believe the issue/question that JJS raised can be posed under this ATRT2 item. I also believe he had proposed drafting a statement on the ALAC mail.

Cheryl Langdon-Orr:++++ to Alan

Rinalia Abdul Rahim:What prohibits ALAN from drafting as a member of the ALAC?

Jean-Jacques S.:@Alan, that's one of the points: the whole "review" culture in ICANN is designed to keep the children fed and quiet (and polite, if possible). I don't believe the review process really addresses some of the larger (over-arching) issues.

Carlton Samuels:++++1 to Alan: We can but the larger picture - and the strategic imperatives per Evan's initiation - need to signaled as well.

Rinalia Abdul Rahim:Is the ATRT2 hat more important than the ALAC hat? And ALan being our liaison to GNSO with the most experience in PDPs - to have you hamstrung is ridiculous.

Alan Greenberg:@Rinalia. Nothing prohibits me drafting, but it does really constrain how much I can push for the ATRT to focus on those issues if I do.

Rinalia Abdul Rahim:@Alan, fodder based from experience from you ratified by ALAC becomes an ALAC view, not an ALAN view.

Evan Leibovitch:What is you just start dumb and work to smarten it up?

Evan Leibovitch:Olivier: it may be valid to comment on registrars not registries because, as the "retailers" of domain names they are closer to end users

Holly Raiche:@Alan - I take what you are saying. But there is still a need - which we would like to be part of - in putting flesh on the proposal

Alan Greenberg:We have had very few complaints about RAs in the past.

Alan Greenberg:@Holly. Certainly, and if/when a PDP starts we do not have strong participation in that, we have some explaining to do.

Cheryl Langdon-Orr:Understood... Yes decertofy but have your records show NO impediament to future re acreditation ON the record

Garth Bruen:In this letter you will find the details of change to the contract with has ZERO transparency.

Olivier Crepin-Leblond:ok -- sure!

Garth Bruen:The change was not disclosed in previous summary docs. The change was submitted by "ICANN Economic Advisors" who are never identified, citing "Extensive Economic Studies" which were never pulished.

Garth Bruen:A direct request to the NT staff to identify the advisors and post the study have been ignored.

Garth Bruen:This as phantom contract change which should not be tollerated by ALAC.

Garth Bruen:It is a prime example of why our oversight is needed in the negotiations.

Yaovi Atohoun:@ Olivier : Has the requester given reason for the first ALS?

Garth Bruen:From my letter: "The community does not even know if this "negotiation" took place in thesame venue or context as the other RAA changes with the full NT membershipresent. In a strict reading of the change it appears ICANN recommended thechange to itself. In short, because this change does not have communityreview it cannot have community support."

Heidi Ullrich:Olivier has dropped. Adigo is dialing him back

Olivier Crepin-Leblond:I am listening on Adobe

Holly Raiche:@Sala - in both cases, decertification is at the request of the organisation - we aren't stepping in - we are justdoing what we have been asked to by a Pakistani

Carlton Samuels:@CLO: This IS what I can recall..and it still makes perfect sense to me!
