

LACRALO Bylaw Working Group

During the preparations for the 2010 LACRALO Officer elections in March, several members pointed out that the LACRALO Bylaws needed to be revised to keep up with a maturing organisation. The bone of contention was the length of the officers terms which were causing considerable confusion. The confusion stemmed from differing interpretations of the "letter of the law" vs the "spirit of the law". Some members were under the impression that it was implicitly agreed during the 2009 Mexico City General Assembly to extend the officer terms from one year to two. However, the LACRALO bylaws were not formally modified to reflect this change and several members pointed out that they did not consciously agree on such an extension.

Over the course of the following deliberations, additional areas for possible Bylaw revisions were highlighted.

Working Group Mandate

Possible Areas for Modifications:

6. The election of the LACRALO chair and secretariat would be done by a LACRALO general assembly (virtual or face to face) convened for a set period (e.g 6 months) prior to the start of the terms of the chair and the secretariat.	6.
