On 22 August 2017 at 03:00 UTC / 11:00 SGT, Krista Papac, ICANN's first-ever Complaints Officer was in Singapore to hold a webinar with APAC community members. Krista discussed the objectives of the Office, gave an overview of the type of complaints that should be directed to her, and shared observations since the Office opened six-months ago.

The Complaints Office was established to provide a centralized mechanism to track complaints regarding the ICANN organization. For example, complaints about how a request has been handled, a process that appears to be broken, insufficient handling of an issue, or something that may be an indication of a systemic issue, among other things.

This webinar was a great opportunity for APAC community members to converse directly with Krista, to share suggestions or feedback for the ICANN Organization, and to ask questions.

Introduction to Registrar Accreditation & Policy Updates

Our Registrar Services Team took us through the process of becoming an ICANN-Accredited Registrar during the APAC webinar on Thursday, 9 October. It was an opportunity for entities who are interested to apply to learn more about the required documentation, fee structure, payment methods as well as how ICANN evaluates applications.

In addition, the team also provided updates on the Additional Whois Information Policy (AWIP) policy and Inter-Registrar Transfer Policy (IRTP), which will take effect on January 31, 2015. The implementation of these policies will help registrants better understand their domain status as well as to ensure a smoother domain name transfer process between registrars.
