Allan Skuce:Looking ahead to ATLAS 3.

Olivier Crepin-Leblond 2:sorry for the delay in logging in -- it took 9 times to try and connect to AC

Allan Skuce:We need some examples to work with.

Terri Agnew:Welcome Darlene Thompson

Allan Skuce:Maybe a small regional discretionary fund.

Darlene Thompson:My apologies for being late - another meeting ran long. Am listening on adobe

Olivier Crepin-Leblond 2:@Allan: indeed -- there is not such thing at the moment

Cheryl Langdon-Orr:good point @alan

Wolf Ludwig:Plus 1

Wolf Ludwig:Outreach without particular resources has proved to be difficult!

Yuliya Morenets:agree Wolf

Olivier Crepin-Leblond 2:IPv6 migration is borderline

Olivier Crepin-Leblond 2:New gTLDs is within the bounds

Olivier Crepin-Leblond 2:ICANN Accountability. Or transition of Stewardship of IANA contract for example is within bounds too, in my opinion

Olivier Crepin-Leblond 2:I would even venture to say that ICANN Studienkreis should be within bounds too

Olivier Crepin-Leblond 2:Good point, Dev

Wolf Ludwig:Two years ago EURALO co-organized a Briefing event on new gTLDs together with Swiss OFCOM in Berne.

Wolf Ludwig:I tried to get support for sending EURALO members to ICANN Studienkreis meetings several times -- what was always rejected!

Olivier Crepin-Leblond 2:...and yet Fadi attended ICANN studienkreis, didn't he?

Wolf Ludwig:Yes, Fadi attended twice -- last year in Italy and this time in Sofia.

Wolf Ludwig:Well, recommendations won't hurt anybody ;-)

Olivier Crepin-Leblond 2:dropped from the call -- but I can hear through the AC room

Allan Skuce:agree with Dev about having details in appendices.

Olivier Crepin-Leblond 2:@Dev: the declaration could not be 100 pages long. so it was really summarised. But now that we can split the recommendations, it's possible to expand on them. Perhaps going back to the original TG work would also be of help?

Olivier Crepin-Leblond 2:back

Alan Greenberg:I'm afraid I have to drop off now. Late for other commitment.

Terri Agnew:goodbye Alan

Allan Skuce:Collaborations.

Terri Agnew:We are trying to find echo

Wolf Ludwig:To my memory: ALAC events like the "10 years ALAC anniversary" in Prague wouldn't have been possible without additional sponsoring from Afiliias.

Wolf Ludwig:And Afiliias has "helpd out" in other cases as well!

Olivier Crepin-Leblond 2:Afiliias, Google, Cira, PIR... these are all organisations that have sponsored At-Large events but in every case, it was direct interaction with those organisations that yielded this sponsorship

Olivier Crepin-Leblond 2:@Dev: yes, that's right. This was the recommendation from members in the group

Terri Agnew:@Oliiver, we are dialing back out to you

Olivier Crepin-Leblond 2:I meant to say that what Dev said is also what I heard on that WG

Allan Skuce:Examples would be beneficial.
