Greg Shatan: (08:17) We can make it a priority for WS2, but we need to look at all of the issues in WS2 to decide how to prioritize them.

Greg Shatan: (08:18) Holding the IANA Transition hostage to an SO/AC accountability discussion strikes me as a very bad idea.

Sébastien (ALAC): (08:20) But what to have a board accountable to a non accountable community

Sébastien (ALAC): (08:20) SO/AC are not so different than the board regarding accountability

Greg Shatan: (08:20) Why do you assume it's a non-accountable community?

Greg Shatan: (08:21) I disagree with that characterization.

Sébastien (ALAC): (08:22) No pb I desagree with you @Greeg

Greg Shatan: (08:22) It can certainly be reviewed, and perhaps improved. But the idea that they are "unaccountable" until some review says otherwise assumes much too much.

Sébastien (ALAC): (08:22) It is not what I said

Greg Shatan: (08:23) You called it a "non accountable community." Seems pretty close, but perhaps I am missing the distinction.

Sébastien (ALAC): (08:24) Not différent on what we said about the Board

Jonathan Zuck (IPC): (08:25) Well, the primary difference between the community and board is the capacity for dynamic participation. The community is not fixed for any period of time.

Sébastien (ALAC): (08:29) But their leaders yes

Sébastien (ALAC): (08:31) @Jan it was before the creation of the WP3

Greg Shatan: (08:31) Leaders come and go as well.

Sébastien (ALAC): (08:31) By AFNIC

Greg Shatan: (08:31) Hopefully, not too quickly....
