 - Review of the designated community members noted that this has been captured in the Google doc according and lists groups according to the bylaws.  - Raised some concerns over the questions drafted as they may be difficult to answer for some groups, as there is a need to understand the terminology i.e. what does it mean to participate.
 - Might be a need to consider to customize the questions based on the SO
 - /AC. It may be a better solution to provide a prefix to the questions so that the group
 - can respond as it applies to them. Customizing questions may make the responses hard to collate and if a questions does not apply, then the organization does
 - not need to reply. there is also a need to have fee text questions too. It should be noted that each question should be interpreted in the cont ext applicable to that AC/SO.
 - May need to revisit the use of the term designated community and explain what we mean when using that term. Might be a better approach to use a clear description

from the bylaws as to the community and who they represent.

- Need to also look at if each group is accountable to the global stakeholder community
- Need to look at restated questions prepared by Giovanni and consider approach to take with the revisions

 - Discussion of the contents of the staff report, it was noted that the staff report does not go into a deep dive as to the SO /AC accountability documents and procedures that exist today.
 - can consider asking the SO.AC Chairs if their support staff cold provide each groups accountability documents

Alan Greenberg: Each question should be interpreted in the context aplicable to that AC/SO.

Steve DelBianco [CSG]:the only terms that need to be customized are "designated community" and "eligible"

Julf Helsingius:yes, we can hear you

Cheryl Langdon-Orr (CLO) 2:YES we hear you

Cheryl Langdon-Orr (CLO) 2:your concerns are nted Kavous... hopefully your prediction of faiure in usefullnss of response will not come to fruition, but we 'can but try' IMO

Steve DelBianco [CSG]:in Bylaws, GNSO "Open to registries, registrars, commercial stakeholders (BC, I{C, ISPCP}), non-commercial stakeholders."

Farzaneh Badii:do we need to change the term designated community?

Cheryl Langdon-Orr (CLO) 2:So avoid the "designated Community Reference then Greg>...

Olga Cavalli:Hi apologies for being late

Cheryl Langdon-Orr (CLO) 2:noted Olga... thanks for joining

Greg Shatan: We need to deal with both the actual members, and the larger group to which each SO/AC is "open".

Cheryl Langdon-Orr (CLO) 2:I agree Greg, and of course even with the example of the ccNSO they have always made great efforts to include and be open to engagement of the NON Member ccNSO Managers

Steve DelBianco [CSG]: @Cheryl -- then teh ccNSO can respond by saying they are open to non-members too.

Cheryl Langdon-Orr (CLO) 2:Yes tht is what we need to tease out wth our enquiry

Greg Shatan:So the question is how is ccNSO accountable to (a) the members, and (b) all ccNSOs.

Greg Shatan: Hard to understand Kavouss, due to peak gain distortion.

Cheryl Langdon-Orr (CLO) 2:Yes Greg indeed

Cheryl Langdon-Orr (CLO) 2:And of course we all need the full CCWG also will review our final questions

Greg Shatan:In that case, should an SG respond as to GNSO accountability or the accountability of that SG?

Greg Shatan:Or should they respond as to all of the SG/Cs?
