Congo, Iran, Iraq, Liberia, North Korea, Sudan, Syria, and Zimbabwe.

Milton Mueller: (08:33) 6 countries, Wale.

Milton Mueller: (08:34) oh, more than 6

Bernard Turcotte - ICANN: (08:34) time check - 27 minutes left in call

Wale Bakare: (08:34) Thanks, Milton and Jeff

Jeff Neuman: (08:35) Venezuela was just sanctioned yesterday, but I think that is limited to a person

Jeff Neuman: (08:35) or people

Milton Mueller: (08:35) yes, it's individuals not the country

Farzaneh Badii (Badiei): (08:36) Thank you

Jeff Neuman: (08:36) It seems like Burma and Ivory Coast sanctions ended last year

Christopher Wilkinson (CW): (08:36) Sorry, that has to be rephrashed. It sounds just like a copout by ICANN.

Wale Bakare: (08:36) How would the registrars, registries of the sanctioned countries and/or individual affected now with ICANN activities?

Philip Corwin: (08:37) What I am hearing is that ICANN does not provide legal advice to contracted parties or act as a law enforcement body.

Greg Shatan: (08:37) I note that the "copy and pasted" registrant agreements also have the following language, though neither are in India: " All dates and times relevant to this Agreement or its performance shall be computed based on the date and time observed in Mumbai, India (IST) i.e. GMT+5:30"

Milton Mueller: (08:38) that is weird

Kavouss Arasteh: (08:40) Sam , Greg, The areas that ICANN has no answer rthen sub Group should answer g

Steve DelBianco 2: (08:40) contract parties may do business that does not involve ICANN contracts in any way, and these activities may be restricted by various sanctions in multiple countries

Farzaneh Badii (Badiei): (08:41) yes Steve. but can ICANN clarify that because of its contract with registrars they don't have to follow OFAC?

Wale Bakare: (08:41) I think, the idiscussion around immunity, raised in previous meetings may not just fade away

Kavouss Arasteh: (08:41) May answers given stemmed from the applicability of US Law then we have to find a way to resolve thaose area

John Laprise: (08:41) Kavous: ICANN can't. The particulars of each case vary too widely.

Christopher Wilkinson (CW): (08:42) Well, I have some doubts about the omnisceince of the business operators. Could ICANN survey all ccTLDs as to whether or not the law applies to them and in which way?

John Laprise: (08:43) Christopher: I'm not sure operators would be willing to disclose particulars of business operations.

Steve DelBianco 2: (08:44) Sam, can you say "Contract parties are not obligated to follow OFAC solely on the basis of their havinga contract with ICANN. "?

Farzaneh Badii (Badiei): (08:44) oh yes that was my question Steve

Farzaneh Badii (Badiei): (08:44) thanks for putting it accurately. I will lower my hand

Steve DelBianco 2: (08:45) Thanks, Sam. I think that statement, provided in writing from your office, could clear up some problems

Kavouss Arasteh: (08:45) Sam, several questions tha I raised were neither replied properly and completely or they were not answered at all or the answers given were irrelevant

Farzaneh Badii (Badiei): (08:46) yes I think it does Steve. I agree

Kavouss Arasteh: (08:46) Sam, Greg, I nned written convincing answers to my questions in a logical, legally valid and in written form

Cheryl Langdon-Orr (CLO): (08:46) this is all helping me understand more thanks Sam

Christopher Wilkinson (CW): (08:47) "John Laprise: This is not about their business operations. It is a question of the applicability of OFAC to their domestic situation. CW

Greg Shatan: (08:47) Kavouss, it was hard to discern the questions in your intervention. Staff will go through the transcript and try to identify the questions.

Wale Bakare: (08:49) Ea

Farzaneh Badii (Badiei): (08:49) I think it should be a requirment for ICANN to seek an OFAC license

Kavouss Arasteh: (08:49) The questions that I sent to you plus those raised or being raiswed during the call as well as those in the chat

Wale Bakare: (08:50) Exactly, ICANN should shoulder the responsibility

Bernard Turcotte - ICANN: (08:51) time check - 9 minutes left in call

Bartlett Morgan: (08:52) having a hard time following kavous

Milton Mueller: (08:52) he asks is DNS an asset or not?

Milton Mueller: (08:53) but it takes 5 minutes

Farzaneh Badii (Badiei): (08:53) hmm we could write a 200 page on that

Bartlett Morgan: (08:53) @Milton thanks

Wale Bakare: (08:54) @Farzaneh, "a 200-page" on what, if i may ask?

avri doria: (08:54) Is it ICANN's question to ask?

Kavouss Arasteh: (08:54) Sam, fair enough. tHEN if ICANN CAN NOT TAKE ACTIONS ON THIS WHO COULD OR MUST ADDRESS THAT? nO DOUBT, ccwq AND ITS ¡URISDICTION SUB GROUP

John Laprise: (08:55) ICANN can't assume that responisibility: they don't have the standing. The US Govt and the operator are the ones.

Milton Mueller: (08:55) There are two others in the queue

avri doria: (08:56) John, it can't for the Rr & Ry, but it can for the functions it provides.

Kavouss Arasteh: (08:57) sAM ,OFAC was not designed to cover DNS

Philip Corwin: (08:57) As this is a subgroup of the Accountability CCWG, isn't the most important question whether the existence of OFAC frustrates any aspect of ICANN accountability? I'm not seeing any reason to believe that it does.

Wale Bakare: (08:57) @John, who are the maintainers of the DNS root server?

Farzaneh Badii (Badiei): (08:58) thanks

Jeff Neuman 2: (08:58) The only thing I think that really relates is to codify this existing practice

Wale Bakare: (08:58) *servers*

Farzaneh Badii (Badiei): (08:59) we should probably change this language in registrar accreditation agreement? "However, Applicant acknowledges that ICANN is under no obligations to seek such licenses and, in any given case, OFAC could decide not to issue a requested license"

John Laprise: (08:59) Avri: only to the extent that it has knowledge and standing, right?

Kavouss Arasteh: (08:59) Sam, We are hearing contradictory statements, on the one hand we have heard that ICANN has no obligation to require Registries and Registrar to prevent providing DNS to the requesters and on the other hand you said OFAC applies to all cases in regard with the countries subject to OFAC.

Jeff Neuman 2: (08:59) In other words, I am not a fan of the language that says that ICANN is not under an obligation to even try and seek a license. I know legally that protects them, but I do think that ICANN should have an obligation to seek the license

Farzaneh Badii (Badiei): (08:59) I have another question from Sam about the lenght it takes to receive a licence for new gtld applicants

Farzaneh Badii (Badiei): (08:59) but I can ask it on the mailing list?

Kavouss Arasteh: (08:59) wHICH IS RIGHT AND WHICH IS WRONG, Pls answer that issue ion reply you willé provide

Jeff Neuman 2: (09:00) obviously it cannot control what Treasury does
