## ALAC Selection Timetable for 2018 ALAC Members Adapted for LACRALO:

- 23 April 2018 - Announcement of call for nominations and Nominee's Statement.\*
- 23 April – 4 May 2018 - Nomination period (nominations accepted for 10 working days).
- 11 May 2018 - Deadline for nomination acceptances
- 14 May - 17 May 2018 - Calls with the candidates if desired by the RALOs. LACRALO's call scheduled for 15 May.
- 18 May - 24 May 2018 - Elections (If required, elections will begin no later than one week after the deadline for nomination acceptances and end no later than two weeks after that deadline).
- 25 October 2018 AGM [ ICANN 63 ] - Newly elected ALAC Members and RALOs Leaders shall be seated at the ALAC Wrap Up Session during the 2018 AGM
